Dolwyddelan Area Appeal

Dear friend.

You may not be aware that the National Eisteddfod, Wales' leading festival will be visiting Conwy County in August 2019. The process of organising the Eisteddfod is a huge community based project providing wonderful opportunities for the host area to participate by organising fundraisers to raising awareness of the festival. The Executive Committee has set a target of £320,000 as the area's contribution to the overall cost. A portion of this, £5,000 has been allocated for our area.

I am writing to ask if you would be willing to consider contributing towards the appeal fund to assist the Dolwyddelan area to reach our target. It would be a great shame if you were deprived of the opportunity to contribute towards this great festival because nobody bothered to ask you... so here is your chance!

Single contribution (top part of the enclosed form)

To make a single contribution to the local appeal. Cheques should be made payable to "Eisteddfod Genedlaethol Cymru 2019".

However, should you wish to make a contribution by direct debit or standing order mandate to enable donors to make serial payments over a specified period of your choice, please refer to the bottom of the form.

Gift Aid: If you pay income tax, you are eligible to complete the Gift Aid Declaration, which will enable the Eisteddfod as a Charitable Incorporated Organisation to reclaim from the Inland Revenue 25p for every pound donated at no extra cost to you. Your donation and the gift aid sum will count towards our local target.

Every donation over £50 will be listed in the Eisteddfod Programme, and prize donations will be acknowledged under the relevant section in the Competition Syllabus and the Programme. Either way, every penny will go towards our area's appeal target.

Conwy County welcomes the National Eisteddfod in 2019. It is Wales' largest arts festival celebrating over 800 years of tradition. With an annual cost in excess of £4 million, the Eisteddfod has a local appeal fund target of £320,000 to raise. With the *Gift Aid* scheme the National Eisteddfod as a Charitable Incorporated Organisation can claim back 25% of the tax paid on your donation, however small, as long as you are a UK income or capital gains taxpayer.
